- · July 2, 2024 through July 31, 2024- \$55.00 late fee (for a total of \$110.00)
- · After August 1, 2024- \$110.00 late fee (for a total of \$165.00)

- · If you renewed on-line do not use this form.
- · In order to continue practicing architecture, you must renew the license registration no later than June 30, 2024.
- · To a print a certificate of licensure go to the resources section of www.ncbarch.org, select architect search, select 'licensee' and search by name or license number. The matches will appear, click on your license number, then click on 'create a certificate'.
- · If you do not renew by June 30, 2024, your license will expire. If you offer or render architectural services after your license expires you may be charged with non-licensed practice of architecture.
